Official Information request and response

Thank you for your request under the Official Information Act ("OIA") dated 5 July 2023.

You have requested:

- All transactions made by the Commission for the months of January, February, March, April,
  May and June 2023. A date of payment, cost centre and GL code, applicable descriptions, the
  other party and whatever notations are available for what the payment related to.
  - Please provide each month in a separate excel tab.
  - Please provide the Commissioner and COO's expenses for the same time period as the above.

We decline to release some of this information under section 18(d) and 18(f) of the OIA.

General ledger transactions (declined under s18(f)) includes private information (s9(2)(a)) and commercial matters (s9(2)(b)) that would involve substantial, detailed consultation and external advice. We are a small agency and this is an onerous request. However -

- we note that detailed financial information is available in each of our annual reports here
   <u>Accountability documents | Retirement Commission Te Ara Ahunga Ora</u>. The 2023 annual
   report is being drafted now.
- we also note that we annually supply Select Committees with very detailed operating information.
- if there is a specific topic about which you are seeking information, we may be able to provide this if sufficiently narrow in scope.
- The Commissioner's expenses (declined under s18(d)) are released annually and are here Accountability documents | Retirement Commission Te Ara Ahunga Ora.

We release the COO expenses in the table below. The COO is a new position and the incumbent commenced in March 2023.
