You have requested:

1. Actual and Budgeted Expenditure:

Please provide a breakdown of the actual and budgeted expenditure on PR and Communications support for the current financial year, as well as the previous two financial years, for Te Ara Ahunga Ora.

Te Ara Ahunga Ora Retirement Commission relies on internal expertise for the majority of our communications and PR work. At times we will engage specific expertise, for example when we need a translation for Māori focussed communications releases or proof-reading and peer reviewing content with specialised financial information. Therefore, we generally have a nominal budget of up to \$10,000 for consultants/advice if/as needed.
